Dear Parent, Guardian, Legal Custodian,

Standardized testing for those home schooled students who require such tests, either for baseline measures or for the annual assessment, can be taken at the local school district, at the area education agency, at a nonpublic school or testing service. If you select testing in the local district or in your home, begin by contacting the superintendent of your local district. If you select testing at the area education agency, complete the enclosed reply form and mail it directly to me.

The standardized tests will be administered at the area education agency on the mornings of **Wednesday, April 22 and Thursday, April 23, 2026 from 8:30 to 11:30 am.** The tests will be administered at the Grant Wood Area Education Agency, 4401 6th St. S.W. (across from Hawkeye Downs) in Cedar Rapids, IA.

Students will be administered half of the required tests on the first date and the second half of the required tests on the second date. Therefore, students must be present on both dates to complete the required tests. Students must report no later than 8:30 a.m. on both days ready for testing. Students should also bring something to quietly work on or read if they should finish a test before the allotted time has expired.

To ensure that adequate equipment and materials are available, the enclosed reply form must be completed and returned to me on or before **February 20, 2026.**
